### **Personal Data Protection Policy**

Dear Valued Visitors,

Pursuant to the enforcement of the Personal Data Protection Act 2010 ("the Act"), PHB provides this Personal Data Protection Policy ("this Privacy Policy") to explain and help you understand how PHB collects and processes your personal information in accordance with the Act. For the purpose of this Privacy Policy, the terms "Personal Data", "Sensitive Personal Data" and "Processing" shall have the same meaning as assigned to it by the Act.

### **Personal Data**

### **Description of Personal Data**

Personal data means any information (in any format, electronic or paper) that relates directly or indirectly to you to the extent that you are identified or identifiable from that information which is collected or provided to PHB for the purposes stated in Paragraph 2 below. Your personal information may include your name, NRIC or passport number, contact details, residential and business address, your occupation, your designation in your company, CCTV images, security recordings, or thumbprints.

#### Source of Collection of Personal Information

PHB collects your personal data directly from you via completion of enquiry, application or registration forms through various channels including emails, teleconversation, online and physical hardcopies at public venues or in any of our premises. PHB may also collect your personal data indirectly from third parties including your employer, agents, or legal representatives. Your personal data may also be collected from cookies through the use of our website.

#### Non-Excessive Collection of Personal Information

PHB will ensure that the personal information collected from you is adequate and not excessing for the purposes stated in Paragraph 2 below.

#### Failure to Provide Personal Data

Personal information requested for in the relevant forms is obligatory to be provided unless it is stated otherwise by PHB. In the event that you elect not to supply the obligatory information or certain categories of data, please note that such failure will adversely affect the processing of your request or provide you with relevant services.

If you are an agent, vendor, supplier or service provider, provision of your Personal Data is mandatory and failure to provide your Personal Data may cause PHB to be unable to engage you to provide services or products or issue payments to you for products or services provided.

# **Purpose of Collection and Processing of Personal Data**

PHB collects and processes your personal data as required or permitted by law and to give effect to business and commercial transaction purposes including the following:

- a. responding to questions, comments and feedback;
- b. internal review of the number of visitors to our website;
- c. processing of requested services;
- d. communication of our future services and events;
- e. data backup, archiving and retention;

#### **Disclosure of Personal Information**

For the purposes stated in Paragraph 2 above, by using secured channels, PHB may share and disclose your personal data to the following relevant entities (located within or outside Malaysia) including the following:

- a. entities within PHB (including its related companies, subsidiaries, holding companies, and associated companies); Your personal data will be held securely and access to your Personal Data is only restricted to designated staff who are contractually required to process your personal information in accordance with their respective job requirements
- b. third parties appointed by PHB to provide services to PHB or on its behalf (including service providers, auditors, lawyers, company secretary, consultants, contractors, and professional advisors);
- c. business partners or affiliates; and
- d. relevant governmental and statutory authorities, local council, industry regulators and law enforcement agencies such as the local police.

#### **Transfer of Personal Data**

We may transfer your Personal Data outside of Malaysia and in such event (if required), the transfer of data does not change our commitments to safeguard your privacy and the information remains subject to existing confidentiality obligations.
